Default and Consequences of Default

In the event that the Customer cancels delivery of Goods the Customer shall be liable for any and all loss incurred (whether direct or indirect) by InteractCard as a direct result of the cancellation (including, but not limited to, any loss of profits).

Privacy Act 1988

The Customer agrees for InteractCard to obtain from a credit reporting agency a credit report containing personal credit information about the Customer in relation to credit provided by InteractCard. The Customer agrees that InteractCard may exchange information about the Customer with those credit providers either named as trade referees by

- (c) advice that interaction is a current result provider to the examiner, (d) advice of any overdue accounts, loan repayments, and/or any outstanding monies owing which are overdue by more than sixty (60) days, and for which debt collection action has been started, (e) that the Quistomer's overdue accounts, loan repayments and/or any outstanding monies are no longer overdue in respect of any default that

- (h) that credit provided to the Customer by InteractCard has been paid or otherwise discharged.
